1. Scope of Work:

The scope of work shall be excavating, area filling, grading and compacting soils for the area designated on the drawing. The work shall include clearing and leveling the top soil including excavation, hauling, dumping & spreading of the soil, under cutting to remove the unstable soil areas, compacting existing soil surfaces and bottom of the excavated areas to receive fills, compacting excavated for sub grid, placing and compacting in fills, dealing with surface water, pumping to keep excavated areas and areas to be filled dry, final grading of designated areas, disposing of unsuitable and excess excavated materials and incidental thereof.

- 2. Contractor Scope of work
- a) The works under the work order/bill of quantities are to be executed as per the designs, drawings & specifications enclosed to this work order as Annexure-I b) Royalty for Gravel / Soil will be paid by MEIL, Contractor should maintain proper documents during transportation. If any penalty imposed by concern departments same should be paid by Contractor.
- c) The contractor shall arrange the required and sufficient water and electricity to the work site and for usage of labourers. The cost of labour hutment, expenses for maintenance of labourers, food and other facilities should be provided by Contractor. The costs for construction of labour colony / huts, taking lease of required land, shall be borne by the Contractor. The item rate agreed herein is inclusive of all such costs and charges.
- d) Contractor shall arrange adequate and suitable machinery and manpower required for the timely and successful completion of the works and Contractor
- e) All necessary Plant & Machinery, consumables, labour, materials, staff and the like required for the successful completion of the works shall be arranged and provided by the Contractor without any delays.
- 3. MEIL scope of work.
- a) The Borrow area only will be provided by the MEIL, which shall pass the CBR (California Beating Ratio Test), FSI (Field Sludge Index Test) etc., From where Agency shall extract the material including transportation & other over heads to work site and shall do Compaction Factor wherein compaction shall not be less than or equal to 95% / 98%, failing to which, contractor shall redo the works at the costs and consequences of the contractor.
- b) The MEIL shall have a right to modify the scope of Work, if required. Such modifications may include increases or decreases in the quantity, character, kind or execution of the Work, or any part thereof. However, the unit rate agreed herein shall be paid to the Contractor in case of any increase. No price escalation will be allowed in the rate for the additional quantities of works allotted to the Contractor.

c) Providing Personal Protection Equipment (PPE) such as gloves, shoes, helmets, safety threads, spectacles etc., on returnable basis. If the contractor not return on end of work the materials cost will be deducted in his RA bill. 4. Rate & deductions: a) The described Item Rate is inclusive of all the costs involved in the scope of work, exclusive of taxes, labour cess& GST (if applicable) will be paid / reimbursed by MEIL to contractor. Applicable Income Tax will be deducted from the invoice amount as per provisions of Income Tax Act and a certificate thereof will be provided to contractor at the end of each financial year				
b) The rates mentioned above are inclusive of costs and charges for equipment, machinery, instruments, temporary works, salaries to staff, labour wages, welfare expenses, cost/charges of testing and inspection of material, works under execution as well as completed works; costs of providing accommodation to staff and labour, providing safety and security arrangements, water, electricity, setting out, supervision, transport, statutory fees/taxes/levies and duties on work contracts and everything not specifically mentioned herein but necessary for performance & completion of work under Work Order. 5. Payment Terms:				
a. The contractor shall submit monthly bills (in the form of Tax Invoice) for the quantities executed and certified by the Project Manager/ Project-in-charge. Along with the Tax Invoice, the contractor shall enclose original certification of the Project Manager / Project-in-charge for the quantities executed/worked during the said month and the payment will be made accordingly. b. Retention Money to be deducted from Bills @5 % will be deducted from each monthly Bill towards Retention Money and the same shall be released after material reconciliation and successful completion of entire scope of work.				
6.General a. The subcontractor shall observe all statutory laws and regulations in force and to maintain sufficient records towards observation of laws. All the works shall be executed as per specifications. b. You shall comply with all safety rules framed by the statutory authorities in the execution of the sub contract work.				
c. In case of accidents, or fatal or injuries non-fatal or damages to plant and machinery, MEIL or client shall not hold any responsibility and the responsibilities lies on the subcontractor. d.
